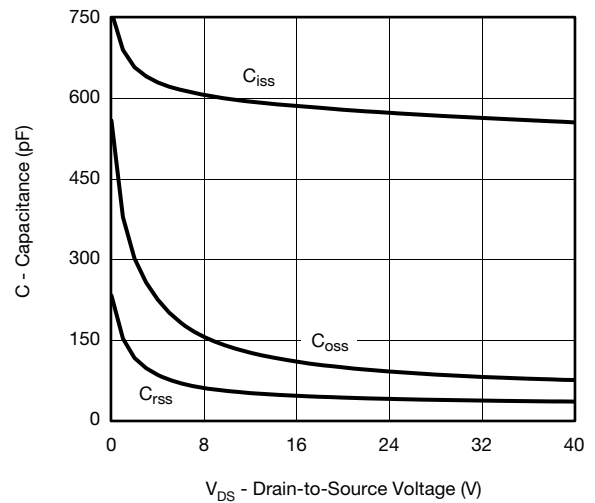
**Output Characteristics**



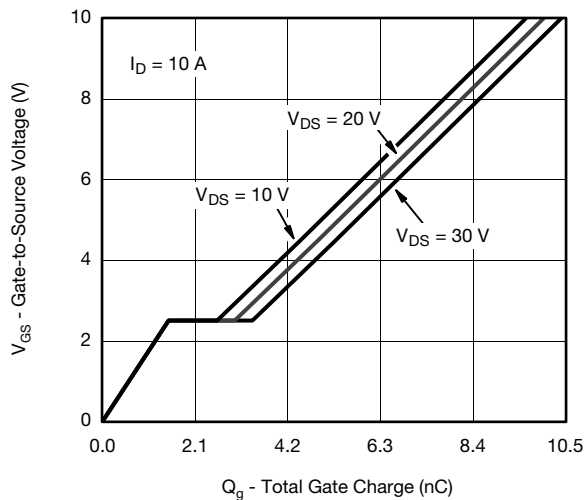

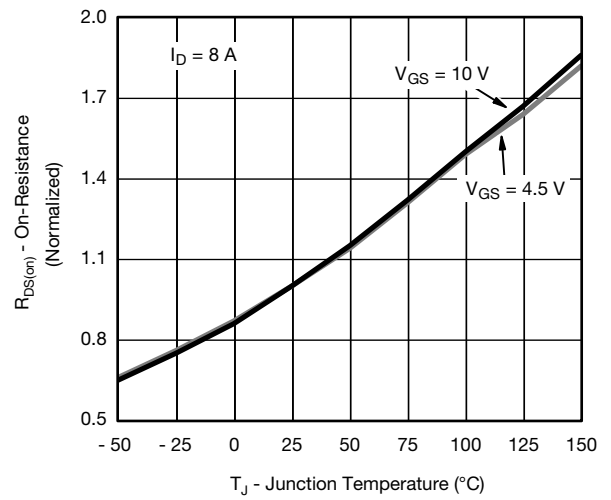
**On-Resistance vs. Drain Current**

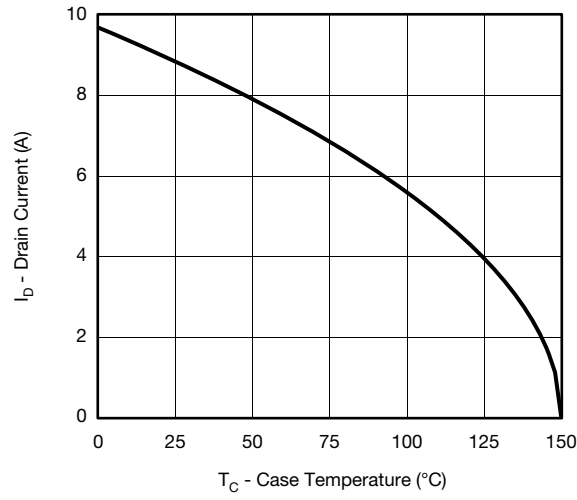


**On-Resistance vs. Junction Temperature**

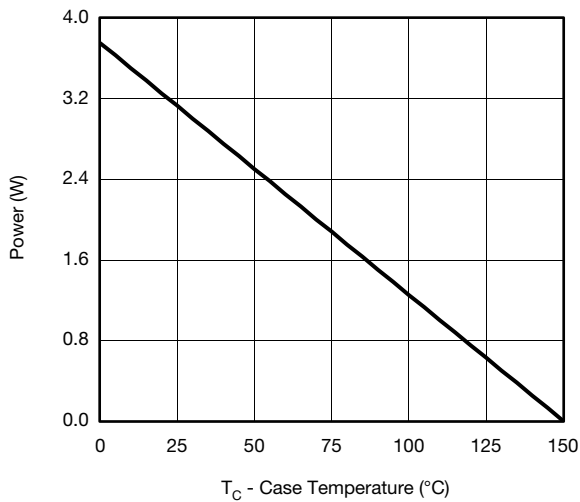

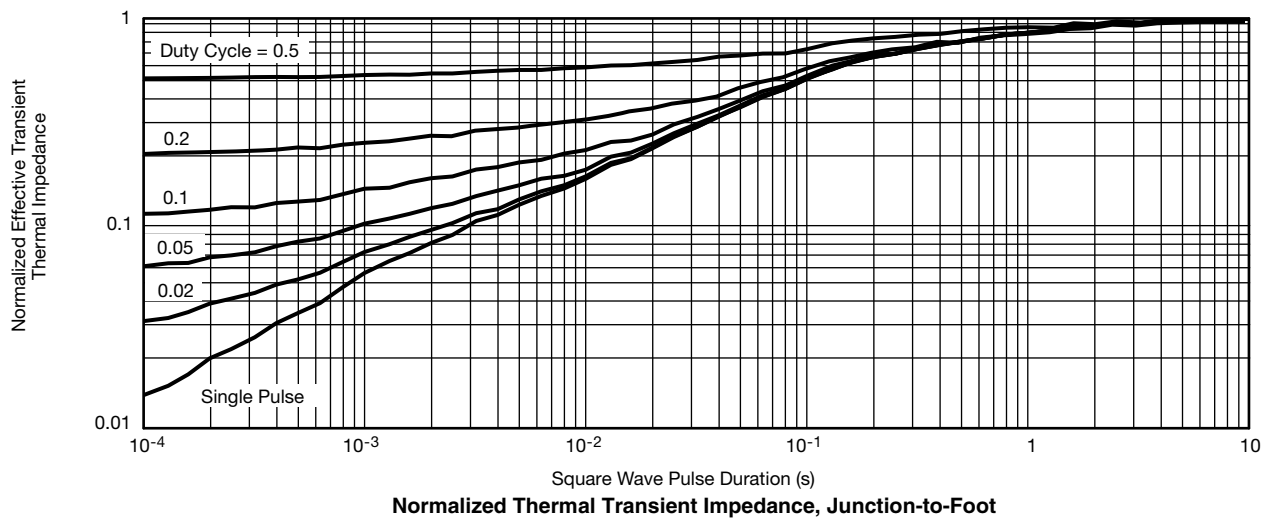
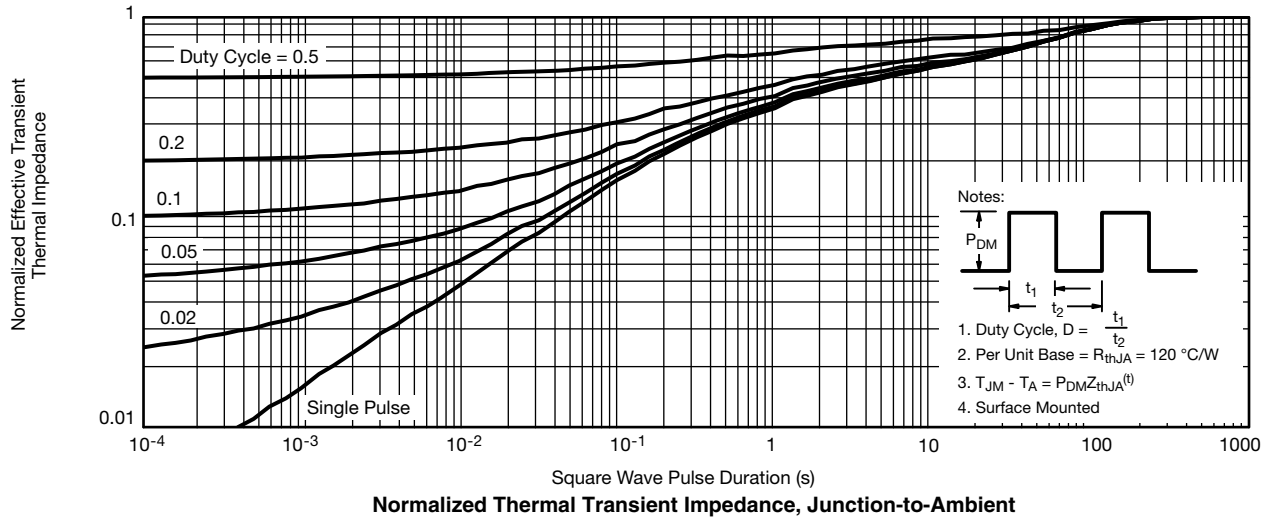
**Power Derating, Junction-to-Foot**
